## **GRANTS: Jim Henry, Vice President & Dolly Sternesky**

#### **Stephen Crane House:**

In compliance with our recent preservation grant, the **lecture room ceiling** work is almost completed (deadline Nov. 1st as per Pew Grant)

As for the driveway, about 20' has been replaced with concrete. It will take more funds to be able to extend it toward the rear.

Jim urged that A.P.H.S. begin an **oral history program**. Eileen is working with the emerging A.P. Museum which already has such a program.

Kay indicated that APTV is currently working with a few organizations on such a project. It was agreed that to avoid redundancy, Eileen could represent both the A.P. Historical Society and the A.P. Museum on oral histories. The Museum will be incorporating oral histories within its digital exhibits. The Historical Society may be able to include oral histories within some of its programs for 2021.

Various upgrades to the working kitchen are being considered.

Tom applied for a small grant to the John Oliver Museum. In exchange for \$10,000 if selected, A.P.H.S. will exhibit John Oliver's art work.

## **PROGRAMMING: Tom Chesek**

1. Regarding Tom's **12-month calendar, "Asbury Park, 1871-2021**," he stated that the trustees should partake in the sales along with designated businesses.

2. Tom is working with Jennifer on a "**Tell Your Asbury Park Story**" and encouraged the trustees to write/share an Asbury Park story to kickstart this project.
